

SECOND USA REVISION – 2010. Application Deadline is 6 August 2010!

A second 2010 US PRE Revision is being planned. If you have horses to be revised you must complete an International Application for Service (attached). The code for Basic Revision is 206, cost \$135 Euros. Complete the remainder of the form per the Book Revision Instructions below. Be sure to include your Breeder Codigo, the horses name & Codigo, and copies of your inscription paperwork with the International Application for Service.

The LG-ANCCE office must have your completed International Application for Service and payment for Revision Services, before you are scheduled for Revision by **6 August 2010, 6pm EDT**.

For those of you with online access, one of the easiest ways to handle payment is via internet. It's fast, easy, and safe. Visa and Mastercard are accepted. Just follow the Online Instructions. Remember the code for Basic Revision is 206 and to print out a copy of your payment receipt. The payment receipt is then sent with your completed application. There are no hassles or exchange rate concerns!

✦ **Helpful tip:** Best way to get your paperwork in is via US Priority Mail, with Delivery Confirmation or Signature Confirmation, sent to the LG-ANCCE address in Miami located at the bottom of this message. Be sure to keep copies of anything you send.

Book Revision Services Instructions:

1. An **International Application for Service (enclosed) need be sent to the LG office in Miami**. Please type your **contact information and exact location for your Ranch clearly**. At the B section of this form, also type **your horse's Name and Codigo**. **Sign this form** at the bottom.

2. **Pay (by credit card) for the service number 206 (135 Euros) no later than Friday, August 6th, 2010 by 6:00 pm Miami local time**. Please find enclosed guidelines for this online payment through our webpage: www.lgancce.com **(Allow pop ups and disable your antivirus to make this online payment)**

(After the above payment closing date and depending of the number of Revisions requested, the LG Miami office will communicate the final dates, itinerary, and specific ranch locations where these revisions will take place.)

Additionally, the following Revision criteria that must be satisfied:

- a. The horse(s) to be Revised must be **under the applicant's name** that is requesting this Revision service. You can request a Change of Ownership – Service # 619 cost \$30 Euros. A copy of your bill of sale is needed for service 619.

- b. The **original horse documentation (Passport or Carta)** must be presented at the Revision site.
- c. The **minimum age** for a horse to be Revised is **three (3) natural years**, therefore if your horse became three (3) years old during 2010 it can be Revised. There is no maximum age limit.

NO Revision services will be provided to horses which do not fulfill all of the above requirements.

In cases where **at least 15 horses to be Revised are in fact assembled** LG-ANCCE will cover all the Veterinarian's travel expenses to that location.

*Please note that if at any one location **the requisite minimum of 15 horses has not been reached**, the participant breeders will be required to pay for the total LG Veterinarians travel expenses from the previous domestic Revision location. (The LG cannot guarantee that this location will be included as a Revision Site in the final schedule for this upcoming Revision Tour).*

In the event a Breeder has paid for a Revision service but cannot present his or her horse/s for this upcoming revision, the payment will be credited to the Breeder and applied to the next Revision tour organized by LG-ANCCE.
